An act to amend Section 12811 of, and to add Section 14901.1 to, the Vehicle Code, relating to vehicles.

LEGISLATIVE COUNSEL'S DIGEST

AB 1725, as introduced, Bonnie Lowenthal. Driver's licenses: identification cards: veterans.

(1) Under existing law, when the Department of Motor Vehicles determines that an applicant is lawfully entitled to a driver's license, the department is required to issue that license to the applicant. Existing law specifies the contents of a driver's license and requires the application for a driver's license or identification card to contain a space for an applicant to indicate whether he or she has served in the Armed Forces of the United States and to give his or her consent to be contacted regarding eligibility to receive state or federal veterans benefits.

This bill would require the application for a driver's license or identification card to also allow a person to present to the department, in a manner determined by the department, a Certificate of Release or Discharge from Active Duty, as specified, and to request the driver's license or identification card be designated with a "V" or another appropriate designation to indicate that the person has served in the United States Armed Forces. The bill would require the department to allow an applicant to present a verification from the county veterans service officer that the person has received that form. The department would be required to print the letter "V" or another appropriate designation on the face of a driver's license or identification card issued

to a person who makes that request and presents that form to the department.

(2) Existing law establishes certain fee amounts for the applications for, and renewal of, driver's licenses and identification cards.

This bill would require the department to charge an additional fee in an unspecified amount to a person who requests that the person's driver's license or identification card be designated, as provided above. The bill would require the department to forward \$1 of the amount collected to the Controller, for deposit in the Veterans Service Office Fund. The bill would require the revenues deposited in the Veterans Service Office Fund to be expended, upon appropriation by the Legislature, for the support of county veterans service offices.

Vote: majority. Appropriation: no. Fiscal committee: yes. State-mandated local program: no.

The people of the State of California do enact as follows:

1 SECTION 1. Section 12811 of the Vehicle Code is amended 2 to read:

12811. (a) (1) (A) When the department determines that the 3 4 applicant is lawfully entitled to a license, it shall issue to the person 5 a driver's license as applied for. The license shall state the class 6 of license for which the licensee has qualified and shall contain the distinguishing number assigned to the applicant, the date of 7 8 expiration, the true full name, age, and mailing address of the licensee, a brief description and engraved picture or photograph 9 10 of the licensee for the purpose of identification, and space for the 11 signature of the licensee. 12 (B) Each license shall also contain a space for the endorsement

12 (B) Each license shall also contain a space for the endorsement 13 of a record of each suspension or revocation-thereof of the license.

(C) The department shall use whatever process or processes, in
the issuance of engraved or colored licenses, that prohibit, as near
as possible, the ability to alter or reproduce the license, or prohibit
the ability to superimpose a picture or photograph on the license
without ready detection.

(2) In addition to the requirements of paragraph (1), a license
issued to a person under 18 years of age shall display the words
"provisional until age 18."

(b) (1) On and after July 1, 2011, an application for an originalor renewal driver's license or identification card shall contain a

1 space for the applicant to enroll in the Donate Life California Organ

and Tissue Donor Registry. The application shall include check
boxes for an applicant to mark either (A) Yes, add my name to the
donor registry or (B) I do not wish to register at this time.

(2) The department shall inquire verbally of an applicant
applying in person for an original or renewal driver's license or
identification card at a department office as to whether the applicant
wishes to enroll in the Donate Life California Organ and Tissue
Donor Registry. Failure or refusal to answer this question or check
a box on the application form shall not be a basis for the department

11 to deny an applicant a driver's license or identification card.

(3) The following language shall be included with the questionrequired by paragraph (1):

15 "Marking 'Yes' adds your name to the Donate Life California 16 Organ and Tissue Donor Registry and a pink 'donor' dot will 17 appear on your license. If you wish to remove your name from the 18 registry you must contact Donate Life California (see back); DMV 19 can remove the pink dot from your licenses but cannot remove 20 you from the registry."

(4) The back of the application shall contain the followingstatement:

25 "If, on the front of this form, you marked 'Yes' to register as an 26 organ and tissue donor you are legally authorizing the recovery of 27 organs and tissues in the event of your death. Registering as a 28 donor will not affect your medical treatment in any way. As 29 outlined in the California Anatomical Gift Act, your authorization 30 is legally binding and, unless the donor is under 18 years of age, 31 your decision does not require the consent of any other person. 32 For registered donors under 18 years of age, the legal guardian shall make the final donation decision. You may limit your 33 34 donation to specific organs or tissues, place usage restrictions, for example transplantation or research, obtain more information about 35 36 donation, or remove your name from the registry on the Internet 37 Web site of Donate Life California: 38 www.donateLIFEcalifornia.org."

1 (5) Notwithstanding any other provision of law, a person under

2 18 years of age may register as a donor. However, the legal3 guardian of that person shall make the final decision regarding the4 donation.

5 (6) The department shall collect donor designation information

6 on all applications for an original or renewal driver's license or7 identification card.

8 (7) The department shall print the word "DONOR" or another 9 appropriate designation on the face of a driver's license or 10 identification card to a person who has indicated on the application 11 his or her intent to enroll in the organ donation program pursuant 12 to this section.

(8) On a weekly basis, the department shall electronically
transmit to Donate Life California, a nonprofit organization
established and designated as the California Organ and Tissue
Donor Registrar pursuant to Section 7150.90 of the Health and
Safety Code, all of the following information from every
application that indicates the applicant's decision to enroll in the
organ donation program:

20 (A) His or her true full name.

21 (B) His or her residence or mailing address.

22 (C) His or her year of birth.

(D) His or her California driver's license number oridentification card number.

(9) (A) A person who applies for an original or renewal driver's
license or identification card may designate a voluntary
contribution of two dollars (\$2) for the purpose of promoting and
supporting organ and tissue donation. This contribution shall be
collected by the department, and treated as a voluntary contribution
to Donate Life California and not as a fee for the issuance of a
driver's license or identification card.

32 (B) The department may use the donations collected pursuant 33 to this paragraph to cover its actual administrative costs incurred 34 pursuant to paragraphs (6) to (8), inclusive. The department shall 35 deposit all revenue derived pursuant to this paragraph and remaining after the department's deduction for administrative costs 36 37 in the Donate Life California Trust Subaccount, that is hereby 38 created in the Motor Vehicle Account in the State Transportation 39 Fund. Notwithstanding Section 13340 of the Government Code, 40 all revenue in this subaccount is continuously appropriated, without

1 regard to fiscal years, to the Controller for allocation to Donate

- Life California and shall be expended for the purpose of increasingparticipation in organ donation programs.
- 4 (C) The department shall transmit to the Donate Life California
- 5 Organ and Tissue Donor Registry and the appropriate policy and
- 6 fiscal committees of the Legislature an annual report, and shall
- 7 make available quarterly updates, detailing funds collected through
- 8 voluntary contributions as well as a summary of applicants,
- 9 including all of the following nonidentifiable information:
- 10 (i) Date of application.
- 11 (ii) Method of application (field office, online, or mail).
- 12 (iii) Donor registration status.
- 13 (iv) ZIP code.
- 14 (v) Gender.
- 15 (vi) Year of birth.
- 16 (D) (i) The annual report to be submitted to the appropriate 17 policy and fiscal committees of the Legislature pursuant to 18 subparagraph (C) shall be submitted in compliance with Section 10 0705 of the Communent Code
- 19 9795 of the Government Code.
- 20 (ii) Pursuant to Section 10231.5 of the Government Code, the
- 21 requirement for submitting the annual report to the appropriate
- 22 policy and fiscal committees of the Legislature imposed under
- subparagraph (C) is inoperative four years after the date the firstannual report is due.
- (10) The enrollment form shall be posted on the Internet Websites for the department and the California Health and HumanServices Agency.
- 28 (11) The enrollment shall constitute a legal document pursuant
- 29 to the Uniform Anatomical Gift Act (Chapter 3.5 (commencing
- 30 with Section 7150) of Part 1 of Division 7 of the Health and Safety
- 31 Code) and shall remain binding after the donor's death despite any
- 32 express desires of next of kin opposed to the donation. Except as
- 33 provided in paragraph (5) of subdivision (b), the donation does
- 34 not require the consent of any other person.
- 35 (12) Donate Life California shall ensure that all additions and
- 36 deletions to the California Organ and Tissue Donor Registry,
- 37 established pursuant to Section 7150.90 of the Health and Safety
- 38 Code, shall occur within 30 days of receipt.

1 (13) Information obtained by Donate Life California for the 2 purposes of this subdivision shall be used for these purposes only 3 and shall not be disseminated further by Donate Life California. 4 (c) (1) All applications for a driver's license or identification 5 card shall contain a space for an applicant to indicate whether he or she has served in the Armed Forces of the United States and to 6 7 give his or her consent to be contacted regarding eligibility to 8 receive state or federal veterans benefits. The application shall 9 contain the following statement:

"By marking the veteran box on this application, I certify that I 11 am a veteran of the United States Armed Forces and that I want 12 to receive veterans benefits information from the California 13 14 Department of Veterans Affairs. By marking the veteran box on 15 this application. I also consent to DMV transmitting my name and mailing address to the California Department of Veterans Affairs 16 17 for this purpose only, and I certify that I have been notified that this transmittal will occur." 18

20 (2) The department shall collect the information obtained21 pursuant to paragraph (1).

(3) As mutually agreed between the department and the
Department of Veterans Affairs, the department shall electronically
transmit to the Department of Veterans Affairs the following
information on each applicant who has identified that he or she
has served in the Armed Forces of the United States since the last
data transfer and has consented to be contacted about veterans
benefits:

29 (A) His or her true full name.

30 (B) His or her mailing address.

31 (4) Information obtained by the Department of Veterans Affairs

32 for the purposes of this subdivision shall be used for the purpose

of assisting individuals to access veterans benefits and shall notbe disseminated except as needed for this purpose.

35 (5) The application for a driver's license or identification card

36 shall also allow a person to present to the department, in a manner

37 determined by the department, a Certificate of Release or

38 Discharge from Active Duty (DD Form 214) issued pursuant to

39 Part 45 (commencing with Section 45.1) of Title 32 of the Code

40 of Federal Regulations, and to request the driver's license or

identification card be designated with a "V" or another
 appropriate designation to indicate that the person has served in
 the United States Armed Forces. The department shall allow an
 applicant to present a verification that the person has received a

5 DD Form 214 from the county veterans service officer appointed 6 pursuant to Section 970 of the Military and Veterans Code. Upon 7 payment of the fee required pursuant to Section 14901.1, the 8 department shall print the letter "V" or another appropriate 9 designation on the face of a driver's license or identification card

10 issued to a person who makes this request and presents the DD11 Form 214 to the department.

(d) A public entity or employee shall not be liable for loss,
detriment, or injury resulting directly or indirectly from false or
inaccurate information contained in the form provided pursuant
to subdivision (b).

16 (e) A contract shall not be awarded to a nongovernmental entity 17 for the processing of driver's licenses, unless the contract conforms

18 to all applicable state contracting laws and all applicable procedures

19 set forth in the State Contracting Manual.

20 SEC. 2. Section 14901.1 is added to the Vehicle Code, to read: 21 14901.1. (a) In addition to the fees required by Sections 22 14900, 14900.1, or 14902, the department shall charge a fee in the 23 amount of _____dollars (\$___) to any person who requests, pursuant to paragraph (5) of subdivision (c) of Section 12811, that the 24 25 person's driver's license or identification card be designated with 26 a "V" or another appropriate designation to indicate that the person 27 has served in the United States Armed Forces.

28 (b) The department shall forward one dollar (\$1) of the amount

29 collected pursuant to subdivision (a) to the Controller, for deposit

30 in the Veterans Service Office Fund created in the State Treasury

31 pursuant to Section 972.23 of the Military and Veterans Code. The

32 revenues deposited in the Veterans Service Office Fund pursuant33 to this subdivision shall be expended, upon appropriation by the

34 Legislature, for the support of county veterans service offices.
