### 1. Identify Your Representatives

### 2. Locate and Engage with District Offices

Legislators' district offices serve as a great starting point to connect with both elected officials and their staff. Staff members are often the first point of contact and can help advance veterans' priorities.

### 3. Make Your Voice Heard

- Call or Email: Introduce yourself and express your interest in veterans' issues. Even if the legislator isn't available, connecting with staff ensures your message reaches the right person.
- Meet with Staff Members: Legislative staff handle policy research, briefings, and recommendations. Educating them on veterans' concerns ensures that decision-makers receive accurate, veteran-focused insights.
- Invite Legislators and Staff to Events: Encourage them to attend veteran-related community events, briefings, or policy discussions. These events help build stronger connections and increase awareness of key veteran issues.
- Be a Trusted Resource: Offer expertise on veterans' matters and position yourself as someone legislators and their staff can rely on for guidance, information, and policy recommendations.

# **Grassroots Lobbying: How to Take Action**

## 1. Stay Informed

Monitor legislation affecting veterans through these resources:

- California Legislative Information View Bills
- → **Sign up for email alerts** to stay updated on bill progress, committee hearings, and policy changes.

### 2. Engage in the Legislative Process

- Submit letters of support or opposition for key bills being considered by the committee.
- Attend Committee Hearings (virtually or in person) and provide public testimony when possible.
- Contact Legislators & Their Staff Directly to express your views on specific bills.
